Pre-recorded sessions

The pre-recorded sessions are short videos (10 to 20 min) designed to prepare and to lay the foundations for the synchronous online sessions. They will provide an overview of the different intellectual property rights (IPRs) as well as specific topics. These videos will enhance the learning experience and interactivity of the live sessions as participants will have acquired beforehand the key concepts and principles of European IPRs to enable them to ask targeted questions to the speakers. This format offers participants greater flexibility and convenience through self-paced learning. Most of the following themes include several videos with a total duration of approximately 13 hours of content:
